Circular

In view of the provision for the recovery / adjustment of un-controllable costs due to increase / decrease in the cost of fuel in case of coal, oil & gas for generating plants through FCA charges. Secretary, MPERC vide letter no. MPERC/RE/2017/1864 dated 27/12/2017 has conveyed Commission's approval for **levy of Fuel Cost Adjustment (FCA) charges @ (-) 4.00 (Minus Four) paise / unit** for the quarter commencing from **01st January, 2018 to 31st March, 2018**.

Therefore the FCA charge for the billing quarter **01st January, 2018 to 31st March, 2018** shall be billed uniformly to all categories of consumers as per the provisions of the tariff order. The rate and amount of FCA charge shall be shown separately in the consumer bills.
