**Circular**

In view of the provision for the recovery / adjustment of un-controllable costs due to increase or decrease in the cost of fuel in case of coal, oil & gas for generating plants through FCA charges, the Secretary, MPERC vide letter no. MPERC/RE/2021/1475 dated 29/09/2021 has conveyed the Commission's approval for **levy of Fuel Cost Adjustment (FCA) charges @ (-) 07 (Minus Seven) paise / unit** for the billing quarter commencing **01<sup>st</sup> October, 2021**.

Therefore the FCA charge for the billing quarter **01<sup>st</sup> October, 2021 to 31<sup>st</sup> December, 2021** shall be billed uniformly to all categories of consumers as per the provisions of the tariff order. The rate and amount of FCA charge shall be shown separately in the consumer bills.
